1. Scope: This addendum covers the *Telephone Based Interpreters Master Agreement* led by the State of New Mexico for use by state agencies and other entities located in the Participating **State of Nevada** authorized by that state's statutes to utilize **Nevada** contracts with the prior approval of the state's chief procurement official.

2. Participation: Use of specific WSCA-NASPO cooperative contracts by agencies, political subdivisions and other entities (including cooperatives) authorized by an individual state's statutes to use **Nevada** contracts are subject to the prior approval of the respective State Chief Procurement Official. Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

3. Participating State Modifications or Additions to Master Agreement:

a. **Contract Term**: This Contract shall be effective upon and subject to Board of Examiners' approval (anticipated to be June 9, 2015) to June 30, 2019, unless sooner terminated by either party.

b. **Consideration**: The parties agree that Contractor will provide the services as specified in the WSCA Master Agreement led by the State of New Mexico. Total contract amount shall **not to exceed \$2,000,000.00**. The contractual authority, as identified by the not to exceed amount, does not obligate the State of Nevada to expend funds or purchase goods or services up to that amount.

c. **Quarterly Reports**: Contractor will provide quarterly sales reports of services rendered to using public agencies within the State of Nevada. Reports shall include the name of the using agency, requested language, number of minutes, and total dollar amount of each call, and shall be sent to the contact for the Participating Entity by the 15th of the following month for each calendar year quarter.


