Hourly rate for telephone consultation only

Telephone rates are based on 15 minute intervals, each interval is priced at \$30, with a minimum of 15 minutes. Each ITS staff member is billed at the same rate.

Hourly rate for services M-F 7:00 a.m. – 6:00 p.m. P.T.

(Including travel costs)

\$120/hr

Onsite rates are based on a one-hour minimum, and then billed just like the telephone rates at 15 minute intervals priced at \$30 an interval. Each ITS staff member is billed at the same rate.

Emergency hourly rate for service hours other than those stated above

(Including travel costs)

\$180/hr

Emergency rates follow both the telephone and onsite 15-minute interval scale. Onsite emergencies are a one-hour minimum, and then billed \$45 per 15-minute interval. Telephone emergencies are billed just like the normal telephone rate, except at the cost of \$45 per interval. Each ITS staff member is billed at the same rate.


