1. **AMENDMENTS.** For and in consideration of mutual promises and/or their valuable considerations, all provisions of the original contract resulting from Request for Proposal #3282 and dated 6/13/2017, attached hereto as Exhibit A, remain in full force and effect with the exception of the following:

- A. The purpose of this amendment is to extend the current contract for six (6) months and increase the not-to-exceed amount by \$3,500,000.00. The new expiration date to be December 12, 2019 and the new not-to-exceed amount is \$11,937,500.

#### Current Contract Language:

3. CONTRACT TERM. This Contract shall be effective as noted below, unless sooner terminated by either party as specified in *Section 10, Contract Termination*. Contract is subject to Board of Examiners' approval (anticipated to be January 10, 2017). Effective from: June 13, 2017 To: June 12, 2019

7. CONSIDERATION. The parties agree that Contractor will provide the services specified in *Section 5, incorporated Documents* at a cost as noted below: Costs will be provided on an as needed basis, based on Agency Projects.

Scopes of Work Awarded: 4.1 Forest Management Hand Crew Services and 4.8 Controlled Fire Services.

Total Contract or installments payable at: Within 30 days upon receipt of invoice.

Total Contract Not to Exceed: \$8,437,500.00

Total Contract or installments payable at: Within 30 days upon receipt of invoice.


Total Contract Not to Exceed: \$11,937,500


