WHEREAS, NRS 333.480 authorizes the Chief of the Purchasing Division to purchase and acquire on behalf of the State of Nevada supplies, materials, or equipment from vendors who have entered into agreement with the General Services Administration or certain other governmental agencies; and

WHEREAS, it is deemed that the supplies, material or equipment are both necessary and in the best interests of the State of Nevada;

NOW, THEREFORE, in consideration of the aforesaid premises, the parties mutually agree as follows:

This Participating Addendum will add the State of Nevada as a Participating State to purchase from the contract between US Communities and Home Depot USA, Inc.-Retail.

1. Scope: This addendum covers maintenance and hardware supplies for purchase by State of Nevada Departments, Agencies and Boards, Nevada Legislative Counsel Bureau, Nevada System of Higher Education, The Supreme Court, and any Nevada Local or Political Subdivision.

Contract Term: This Participating Addendum shall be effective upon approval of the Chief of the Purchasing Division or his designee thru the ending date of the original contract, unless sooner terminated by the Chief of the Purchasing Division or by either party as permitted under the original contract.
