1. Scope:

Unless otherwise defined, all capitalized terms in this Participating Addendum shall have the meanings ascribed to them in the National Association of State Procurement Officials, AED Defibrillators, Advanced Life Support, and Chest Compression Units, Master Price Agreement, # SW300 (the "NASPO Master Agreement").

The following are authorized Purchasing Entities under this Participating Addendum: State of Nevada agencies and local governments (as defined in NRS §332.015) may join and use this contract. Any local government may join or use this contract, subject to all terms and conditions thereof pursuant to NRS §332.195. The State is not liable for the obligations of any local government which joins or uses this contract.

2. Changes:

The following provision is applicable to this Participating Addendum only and is in addition to the provisions contained in Contract Number SW300.

Nevada Reporting: Upon request, Cardiac Science Corporation will provide a sales report showing the gross Nevada Sales.

The report, when requested, will be subtitled by Purchasing Entity name, by State agency, or by political subdivision. The report will also include any adjustments from prior periods, if applicable.

The parties acknowledge and agree that orders submitted to Contractor from a Purchasing Entity through the Purchasing Entity's Business Procurement Card are authorized Purchase Orders under the NASPO Master Agreement.

8. Order of Precedence: The parties acknowledge and agree that:

(a) In the event of a conflict between the terms contained in the NASPO Master Agreement and this Participating Addendum, the terms and conditions of this Participating Addendum will control as between Contractor and the Participating Entity; and

(b) This §8 specifically supercedes §5 of the NASPO Master Agreement




