

**NATIONAL ASSOCIATION OF STATE PROCUREMENT OFFICIALS

This Participating Addendum will add the State of Nevada as a Participating State to purchase from the NASPO Price Agreement, Number MA SW300, with Phillips Healthcare.

1. Scope:

Unless otherwise defined, all capitalized terms in this Participating Addendum shall have the meanings ascribed to them in the National Association of State Procurement Officials, *AED Defibrillators, Advanced Life Support, and Chest Compression Units*, Master Price Agreement, # SW300 (the "NASPO Master Agreement").

The following are authorized Purchasing Entities under this Participating Addendum: All governmental entities within the State of Nevada including all State Agencies, the University and Community College System, the Court System, Legislative Counsel Bureau, Cities, Counties, Public Schools, Institutions of higher education and political subdivisions are authorized to purchase AEDs and Equipment under the Contract.

This agreement is not a purchase order, nor does it guarantee any purchases to be made by the State of Nevada.

Political Subdivision Participation: Participation under this contract by political subdivisions (i.e. colleges, school districts, counties, cities, etc.) will be voluntarily determined by the political subdivision. The contractor agrees to supply the political subdivisions based upon the same terms, conditions and prices.

2. Changes:

The following provision is applicable to this Participating Addendum only and is in addition to the provisions contained in Contract Number SW300.

Nevada Reporting

Upon request, Phillips Healthcare will provide a sales report showing the gross Nevada sales.

The report, when requested, will be subtotaled by Purchasing Entity name, by State agency, or by political subdivision. The report will also include any adjustments from prior periods, if applicable.

6. Price Agreement Number: All Purchase Orders issued by Purchasing Entities within the jurisdiction of this Participating Addendum shall include NASPO Master Agreement number: SW300

7. Purchase Orders: All Purchasing Entities issuing valid Purchase Orders will be bound by the terms and conditions of the NASPO Master Agreement including, without limitation, the obligation to pay Contractor for Service and Equipment provided. The parties acknowledge and agree that orders submitted to Contractor from a Purchasing Entity through the Purchasing Entity's Business Procurement Card are authorized Purchase Orders under the NASPO Master Agreement.

8. Order of Precedence: The parties acknowledge and agree that:

(a) In the event of a conflict between the terms contained in the NASPO Master Agreement and this Participating Addendum,

the terms and conditions of this Participating Addendum will control as between Contractor and the Participating Entity; and

(b) This §8 specifically supercedes §5 of the NASPO Master Agreement

This Participating Addendum and the NASPO Master Agreement together with its exhibits, set forth the entire agreement between the parties with respect to the subject matter of all previous communications, representations or agreements, whether oral or written, with respect to the subject matter hereof. Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Participating Addendum and the NASPO Master Agreement, together with its exhibits, shall not be added to or incorporated into this Participating Addendum or the NASPO Master Agreement and its exhibits, by any subsequent Purchase Order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Participating Addendum and the NASPO Master Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.
