2. **REQUISITIONS:** All State agencies requisitions over \$5000.00 will be processed by and through the Nevada State Purchasing Division and a purchase order issued, as needed, at the contracted price(s). Local governments as defined in NRS 332.015 can purchase directly and be billed by vendor.



