

NIGP Search Aid

The State of Nevada has implemented a new eProcurement system. This new system enables Vendors to connect and do business electronically with the State including responding to Solicitations and receiving Purchase Orders online. To view Solicitations, submit responses, and view Purchase Orders, Vendors must register within NevadaEPro.

The last step in the registration process is to select the commodities and services that the Vendor provides using the National Institute of Governmental Purchasing (NIGP) Codes. This will help to ensure that the Vendor receives notifications and Solicitation opportunities for those commodities and services.

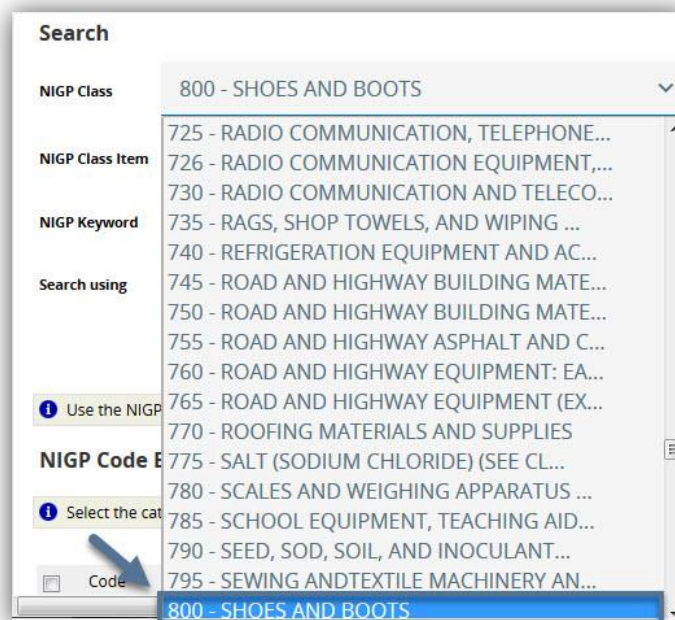
The Vendor can search and select their codes by two ways:

- Search Engine
- NIGP Code Browse

SEARCH ENGINE

NIGP Class Field

Vendors that are familiar with the NIGP Codes can browse and select their codes using the Search Engine. A Vendor can find the specific NIGP Class Code from the NIGP Class field dropdown using the



scroll or can type the first digit of the Class Code to find codes in that number range.

After the Vendor has selected the specific NIGP Class Code from the dropdown, the page will refresh to display the corresponding Class Item Codes in the NIGP Class Item field dropdown and at the bottom of the screen. The Vendor can select the specific Class Item Code from the dropdown or select multiple Class Items Codes at the bottom of the screen.

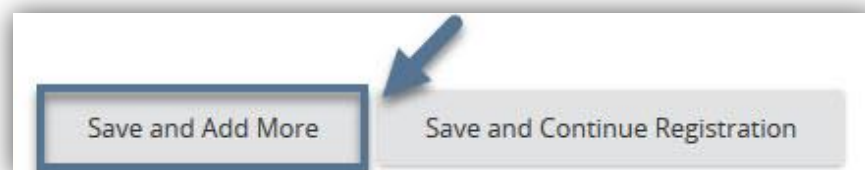
