- 7. **BOYCOTT OF ISRAEL PROHIBITED.** Contractor certifies that it is not currently engaged in and agrees for the duration of this contract not to engage in, a boycott of Israel as defined in NRS 333.338(3)(a).
- 8. GOVERNING LAW: JURISDICTION. This Contract and the rights and obligations of the parties thereto shall be governed by, and construed according to, the laws of the State of Nevada, without giving effect to any principle of conflict-of-law that would require the application of the law of any other jurisdiction. The parties consent to the exclusive jurisdiction of and venue in the First Judicial District Court, Carson City, Nevada for enforcement of this Contract, and consent to personal jurisdiction in such court for any action or proceeding arising out of this Contract.

## Attachment A

- 1. Allegiant Air will provide air travel services on regularly scheduled flights to State of Nevada employees, who will book their flights on a click-and-book solution available via Allegiant.com.
- 2. Allegiant Air will provide State of Nevada employees with a 5% discount on flights between the Reno Airport (RNO) and the Las Vegas Airport (LAS). This 5% discount will apply to all travel-related fees airfare, bags, seat assignments, trip insurance, and priority boarding. No minimum number of flights is required to qualify for the discount.
- 3. Allegiant Air will provide State of Nevada with a monthly access code to apply the \$15 discount. It is the responsibility of the State of Nevada to contact Allegiant Air for the current month's code.
- 4. The State of Nevada is not guaranteeing any minimum amount of business to Allegiant Air and Allegiant Air is not guaranteeing flight availability for Nevada employees.
