What is Changing on May 28, 2025?

Basic Fare: Introducing, Basic. The Basic fare will be the lowest price point and will have less flexibility than other fares (*refer to the updated Fare Chart on next slide*)

Fare names are subject to change

Charging for Checked Bags: For flights purchases or changed on and after May 28, 2025, checked baggage fees will be charged except to the following types of travelers:

- ☐ Business Select: 2 free checked bags
- ☐ A-List Preferred Members: 2 free checked bags
- ☐ A-List Members: 1 free checked bag
- ☐ Chase Rapid Rewards Credit Cardholders: 1 free checked bag
- ☐ Customer with valid group ticket that is ticketed on or before January 26, 2026: 2 free checked bags
- ☐ Active-duty US military members with a valid military ID

Flight Credits Expiration: For flights purchased or changed on and after May 28, flight credits will have an expiration date based on the fare product:

- ☐ Basic Fares: Expire 6 Months from original purchase date
- ☐ Wanna Get Away Plus: 12 Months from original purchase date
- ☐ *Anytime & *Business Select: 12 Months from original purchase date

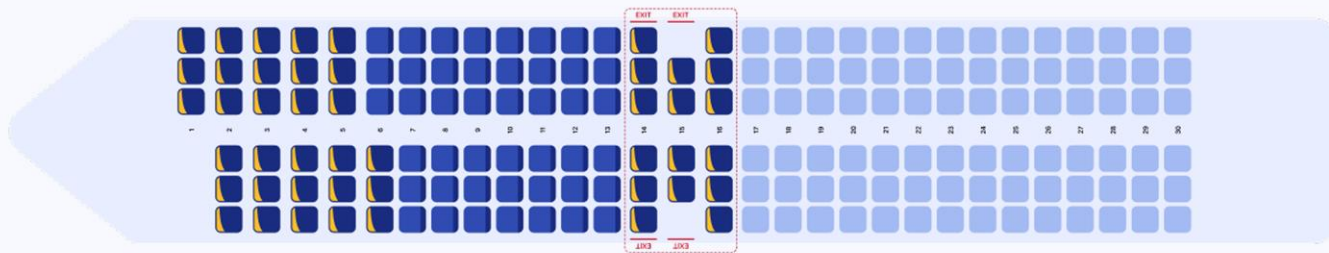
